#### Position

Factory Production Manager based at Nangula Farm, Kasiya Road, off Airwing, Lilongwe

#### Job Purpose

The Factory Production Manager is a senior management leadership position whose post consists of planning, coordinating and overseeing the production of Invegrow's products in factories. There will be multiple production teams for five business lines, although only three will be active in 2023.

- The position will have accountability for: Production Crews

#### **Key Duties & Responsibilities**

- Working with senior management team to come up with weekly harvest/production work plans for cannabis flower, extracts and hemp foods
- Oversee drying and curing activities for flower and manage contamination, climate controlled conditions and tracking on record forms by supervisors
- Oversee the extract line and delicate glassware/equipment that should be operated by a trained manager
- Help oversee the lab manager/technician and ensure quality control is done on material, and samples are taken as needed
- Hemp foods to be packaged and value added on site, and must meet ISO and MBS quality standards before distribution
- The company is auditing for ISO22000 and so all factory standards, SoPs, hygiene, and procedural manuals must be completed and adhered to
- The Manager will organise teams and manage staff, prepare work schedules and assign specific duties to direct reports
